NOTES:

- The Midwest Section was **created** in the summer and fall of **1989** when planners in Fort Worth and the surrounding cities petitioned the state chapter to split from the **North Central Texas Section** (Dallas, etc.). The petition was accepted by the TXAPA Board in October and the Midwest Section began meeting in January 1990. The Midwest Section includes 25 counties and includes the cities of Fort Worth, Arlington, Denton, Wichita Falls, Grapevine, North Richland Hills, Hurst, Euless, Bedford, Benbrook, Burleson, Haltom City, Keller, Stephenville and Southlake.
- Originally there was an **Assistant Director** position in charge of speakers and programs. In 1992, the position was changed to **Director-Elect**.
- In 1993, at the request of the Chapter, an appointed position was added, **Professional Development Officer (PDO)**.
